

Provo, Utah, and Salt Lake City—In general conference, Church President Russell M. Nelson spoke about poverty and other humanitarian concerns. declaring, "As members of the Church, we feel a kinship to those who suffer in any way.... We heed an Old Testament admonition: 'Thou shalt open thine hand wide unto thy brother, to thy poor, and to thy needy' (Deuteronomy 15:11)."
