Richard O. Cowan was a full-time faculty member for fifty-three years and is a professor emeritus of Church history and doctrine at Brigham Young University and author of books dealing with Latter-day Saint temples, history, and doctrine.

Larry E. Dahl is a professor emeritus of Church history and doctrine at Brigham Young University, author of many published articles and several books, and most recently senior editor of the nine-hundred-page *Doctrine and Covenants Reference Companion* (Salt Lake City: Deseret Book, 2012).
